*Learn what **behavioral healthcare providers** need to know to meet medical necessity criteria and be paid for inpatient psychiatric Medicare days.*

Hospitals' fiscal intermediaries (the contractors who determine for the federal government whether to pay an individual claim) have developed (or are in the process of developing) a detailed set of criteria (called local coverage determinations) to use in reviewing inpatient psychiatric medical records for payment. These criteria are based on clinical documentation of admission and discharge criteria, diagnosis, patient assessments, certification, treatment planning, and progress notes.

This **two-hour compact disc training** brings you faculty members who have been involved in the development, review, and refinement of inpatient psychiatric LCDs. The training will help your staff answer questions such as: Who is our FI and what review criteria has it developed? Do our records meet the requirements? What do we need to do to get into compliance? How can we influence the LCD development process with our FI? What can we expect as this process goes forward? **And we will include a link to Web-based background materials to expand the training.**
