Starting January 1, 2005, a new prospective payment reimbursement system (PPS) takes effect for behavioral healthcare providers offering inpatient psychiatric services for beneficiaries under the Medicare program. This two-hour compact disc (CD) focuses on ***the implications and mechanics of inpatient psychiatric PPS for behavioral healthcare organizations***. The training summarizes the key elements of the final rule implementing the new inpatient psychiatric prospective payment system (published in the November 14, 2004, *Federal Register*). The CD helps you understand the financial implications of the final rule and discusses ways to improve the efficiency and lower the costs of your clinical programming.

The compact disc will help you prepare to fully evaluate your current financial and clinical operations and make appropriate changes to address the new payment system.
