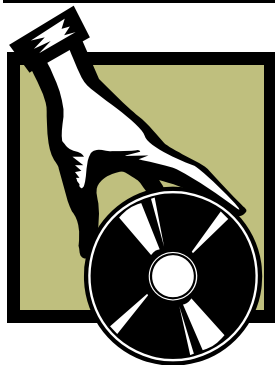

HOSPITAL-BASED INPATIENT PSYCHIATRIC SERVICES (HBIPS) CORE MEASURES:

Implementation Strategies for an October 2008 Launch

A COMPACT DISC (CD) TRAINING & RESOURCE MATERIALS

On June 1, 2008, The Joint Commission (JC) posted final specifications for a set of hospital-based inpatient psychiatric services (HBIPS) core measures. These specifications are available at www.jointcommission.org/PerformanceMeasurement/PerformanceMeasurement/Hospital+Based+Inpatient+Psychiatric+Services.htm. Starting in October 2008, the measures will be available for hospitals to use to fulfill the requirements of performance measurement reporting.

To help psychiatric and addiction hospital settings implement The Joint Commission core measures, the National Association of Psychiatric Health Systems (NAPHS) has organized a special four-hour training on compact disc (CD). Faculty from The Joint Commission provide background on how the accrediting body envisions these core measures being used as part of the hospital accreditation process, including a discussion of the latest Joint Commission policies. Discussants from behavioral healthcare organizations that have pilot-tested the HBIPS measures and worked to use the data to improve care within their facilities share their experiences with the process.
